### **General**

- As from 31/01/2024, in the context of the implementation of the SSO, new technical contact with 'API User' role should be setup and used to run automatic downloads.
- The authentication is now using client ID and client server via the OAuth2 protocol. A new URL is set for the authentication endpoint :
