(*) Metering and settlement charges

In addition to each exit tariff the following charges will be charged according to Section 15 (7) GasNEV (Gasnetzentgeltverordnung – Gas Network Fee Ordinance):

Metering charge	0.02
Settlement charge	0.01

Charges for booking of Exit Capacity for periods of less than a year are calculated with the charges shown above multiplied with the days of the contract duration divided by 365.



Costs of capacity platforms

The costs of the primary and secondary capacity platform are included in the Entry/Exit Tariffs according to Section 12 (1) and (2) GasNZV (Gasnetzzugangsverordnung - Gas Network Access Ordinance).

Contractual penalty for capacity overrun

Hourly capacity overruns according to Section 30 of the General Terms & Conditions of Fluxys TENP GmbH shall establish a claim for charging of a capacity overrun fee by Fluxys TENP GmbH. The fee for an hourly overrun shall be three (3) times of the daily tariff applicable at the day and the point where the overrun occurred.

Specific biogas levy

Fluxys TENP GmbH publishes the uniformly valid specific biogas levy of the market area NCG (NetConnect Germany).

This is charged in addition to the tariffs of exit points to directly connected end consumers and to the downstream network operators.

Exit points to storages, cross-border interconnection points and market area interconnection points are not taken into account in accordance with Article 7 KoV V.

The specific biogas levy for the calendar year 2013 is 0.26 Euro/ kWh/h /a.
