

SCS Rules 2017 Simplification Conversion Service

[March] 2017

1 Introduction

These are the SCS Rules applicable to the 2017 Simplification Conversion Service offered under paragraph 10 of Section B of the IUK Access Code (Issue 4) and these rules apply in addition to the IUK Access Code.

2 Eligible IAA Shippers

Only IAA Shippers that have been allocated Annual Capacity Products for any Gas Year in the Capacity Auction held in [March] 2017 (**Eligible IAA Shippers**) may make an application under paragraph 5 for the conversion right under the Simplification Conversion Service.

3 SCS Window

The SCS Window during which Eligible IAA Shippers may apply for a conversion right under the Simplification Conversion Service is from [xx:xx] hours on [xxxx] [March] 2017 to [xx:xx] hours on [xxxx] [March] 2017 or such other dates as IUK shall notify

4 Eligible Registered Capacity

An Eligible IAA Shipper may apply for a conversion right under the Simplification Conversion Service for “eligible” Entry Capacity and/or “eligible” Exit Capacity where:

- (a) “Eligible” Entry Capacity is Entry Capacity at the Zeebrugge Entry Point allocated to the Eligible IAA Shipper as an Annual Capacity Product in the [March] 2017 Capacity Auction;
- (b) “Eligible” Exit Capacity is Exit Capacity at the Zeebrugge Exit Point allocated to the Eligible IAA Shipper as an Annual Capacity Product in the [March] 2017 Capacity Auction.

5 Application and Deadline

- (a) An Eligible IAA Shipper may apply within the SCS Window for the Simplification Conversion Service for Eligible Entry Capacity and/or Eligible Capacity.
- (b) Such application must comply with these Rules (in particular paragraph 6) and with paragraph 10 of Section B of the IAC.
- (c) An Eligible IAA Shipper may make an application by completing the form in the Annex 1 and submitting it to: [address/ contact details].
- (d) Where an Eligible IAA Shipper wishes to make an application for the Reprofitting Service and for a conversion right under the Simplification Conversion Service in respect of the same Entry Capacity and/or Exit Capacity such Eligible IAA Shipper shall submit a single application that complies with the Reprofitting Rules and these SCS Rules in the form set out in Annex 2.
- (e) The application by an Eligible IAA Shipper for the conversion right under the Simplification Conversion Service will be made in respect of the adjusted amount of Entry Capacity or Exit Capacity (after the deduction of Released Capacity) where IUK accepts an application under the Reprofitting Service in respect of Eligible Entry Capacity and/or Eligible Exit Capacity.

- (f) Any application made is binding on the IAA Shipper and may not be withdrawn or changed without the prior written consent of IUK.
- (g) Eligible IAA Shippers must complete and send to IUK their applications by no later than **the end of the SCS Window**.

6 Conditions

- (a) The application for the Simplification Conversion Service shall be made in respect of each Gas Year for which the Eligible IAA Shipper wishes to have a conversion right under the Simplification Conversion Service;
- (b) An Eligible IAA Shipper shall specify the Months in the Gas Year and the amount of Eligible Registered Capacity for each Month specified for which it wishes to have a conversion right under the Simplification Conversion Service;
- (c) An Eligible IAA Shipper is liable to pay a SCS Charge in respect of the Entry Capacity and/ or Exit Capacity in respect of which it has been granted a conversion right for the Simplification Conversion Service .

7 Acceptance and Notification

- (a) IUK has the right to reject any application as provided in paragraph 10.7 of Section B of the IUK Access Code.
- (b) IUK will notify an Eligible IAA Shipper whether it has been successful in its application in accordance with paragraph 10.11 of Section B of the IUK Access Code.

APPLICATION FOR SIMPLIFICATION CONVERSION SERVICE ONLY

1. We refer to the [March] 2017 Simplification Conversion Service which IUK has offered to Eligible IAA Shippers to apply for a conversion right under the Simplification Conversion Service for Entry Capacity and/or Exit Capacity allocated as Annual Capacity Product(s) in the [March] 2017 Capacity Auction and the [March] 2017 SCS Rules.
2. We are party to an IUK Access Agreement (IAA) with Interconnector (UK) Limited dated _____.

We have read and understood: (a) the 2017 SCS Rules; (b) Issue 4 of the IUK Access Agreement and the IUK Access Code (IAC); and (c) this application and agree that all such documents, as may be modified or replaced, govern this application.
4. In consideration of IUK offering the Simplification Conversion Service, we make an irrevocable and binding application for a conversion right for the amounts of Eligible Entry Capacity and/ or Eligible Exit Capacity allocated in the [March] 2017 Capacity Auction as specified in the table below.
5. We agree, in connection with this application, that:
 - (a) IUK will assess all applications under the 2017 SCS Rules and may reject any application that does not meet the requirements of these rules or paragraph 10 of Section B of the IAC;
 - (b) where, pursuant to this application and paragraph 10.11 of Section B, IUK grants a conversion right under the Simplification Conversion Service for Eligible Entry Capacity and/or Eligible Exit Capacity, that it will be binding on us.
6. We have the power and authority and have obtained all necessary governing body and shareholder approvals to make this application.
7. To the best of our knowledge, at the date of making this application, we will be able to satisfy the Credit Criteria at the time required for satisfaction of the Credit Criteria under clause 2.9 of Appendix A to the IAA.
8. To the best of our knowledge, at the date of making this application, there are no events or circumstances arising or that may arise in respect of us, that are specified under Clause 6.1 of Appendix A of the IAA or that are actual or potential Insolvency Events.
9. We acknowledge that this application constitutes Confidential Information under Clause 9 of Appendix A to the IAA and that the obligations under that clause apply to this application
10. We agree that Clauses 12.11, 13, 14 and 15 of Appendix A to the IAA apply to this application.
11. Capitalised terms not defined in this application shall have the meaning given to them in the IAA or IAC. Cross references to clauses of the IAA or paragraphs or sections of the IAC shall be to such clauses, paragraphs or sections as may be re-numbered or modified.
