INTRODUCTION OF VIP THE-ZTP AS FROM 1/04/2022

On 1 April 2022 Fluxys Belgium (FLX) and German Operators Fluxys TENP GmbH (Fluxys TENP), GASCADE Gastransport GmbH (GASCADE), Gasunie Deutschland Transport Services GmbH (GUD), Open Grid Europe GmbH (OGE) and Thyssengas GmbH (TG) will introduce a Virtual Interconnection Point (VIP), named VIP THE-ZTP, between THE and ZTP. This VIP will combine the interconnection points Eynatten 1 and Eynatten 2.


From 1 April 2022 onwards, all market activities, such as capacity booking, nominations, allocations or invoicing, will be operated on the VIP. Existing contracts are unchanged in nature, quantity, duration or tariff, but will be operated on the VIP as well.

PRODUCTS & CAPACITIES

Resulting from the combination of the products and capacities on Eynatten 1 and Eynatten 2, Fluxys Belgium will offer following products on VIP THE-ZTP: Entry and Exit firm and interruptible capacity in both directions

- Entry and Exit firm and interruptible capacity in both directions
- OCUCs from/to VIP BENE

The available firm capacities on VIP THE-ZTP will be the sum of the corresponding available firm capacities on Eynatten 1 and Eynatten 2.



TARIFFS

The tariffs applicable on VIP THE-ZTP remains the same as the tariffs on the former interconnection points. Therefore, there will be no tariff changes on existing contracts resulting from the introduction of VIP THE-ZTP.
