

Overnomination Rules

Issue 1

1. Introduction

- 1.1 This document sets out the rules that apply to Overnomination, as referred to in paragraph 1.4 of Section B of the Interconnector Access Code ("IAC").
- 1.2 INT may, at any time, update and/or make amendments to this document. INT will publish the latest version to be available on its website via www.interconnector.com.

2. Capacity Product

- 2.1 INT may make Interruptible Capacity available for sale through Overnomination as a Within Day Capacity Product, subject to operational conditions, when;
 - a) All Offered Firm Capacity has been allocated to Shippers; and
 - b) The nominated flow for the current Gas Day is less than 100% of the Contracted Firm Capacity.
- 2.2 All Offered Capacity made available through Overnomination will be Interruptible Capacity, as defined in paragraph 2.1 of Section B of the IAC and is subject to interruption and/or constraint as defined in Section I of the IAC.
- 2.3 Interconnector may withdraw the availability of Overnomination Capacity at any time.
- 2.4 Registered Capacity acquired through Overnomination is allocated from the requested start time until the end of the Gas Day.
- 2.5 A Shipper is entitled to re-nominate Registered Capacity acquired through Overnomination as defined in Section C of the IAC.

3. Publication of Overnomination Information

- 3.1 If Overnomination is made available, INT will publish the following details:
 - i. At which Connection Point(s) Overnomination is available;
 - ii. the direction (Entry/Exit) that the Offered Capacity is available in;
 - iii. the relevant period that Overnomination is available for purchase;
 - iv. any other information that INT determines appropriate.

4. Request and Allocation of Capacity via Overnomination

- 4.1 A Shipper is not required to hold Registered Capacity for the period in question to enter into a Capacity Transaction via Overnomination.
- 4.2 The Nomination must be submitted after INT has published that Overnomination is available for the relevant period. Any Nomination above a Shipper's Registered Capacity made before the publication of Overnomination availability will not be allocated.
- 4.3 Any Nomination above a Shipper's Registered Capacity for a period where Overnomination is active will constitute a Capacity Transaction under Overnomination.
- 4.4 Shippers will receive confirmation via email following the allocation of Capacity confirming the following details:
 - i. The amount of Capacity purchased;
 - ii. the Connection Point(s) and direction;
 - iii. the Capacity Period.
- 4.5 In the event of an Interruption or a System Constraint affecting Registered Capacity booked via Overnomination, the timestamp of each Nomination above the Registered Capacity will be assessed such that the Nominations will be reduced in time order from the last Nomination submitted before the time of the Interruption or System Constraint, in accordance with Section I of the IAC.

5. Charging

- 5.1 The applicable price is the Overnomination Price as defined in the Interconnector Charging Statement.
- 5.2 Shippers will be charged based on the quantity of Registered Capacity purchased via Overnomination rather than their final Confirmed Nomination Quantity against this Capacity.
- 5.3 Before purchasing capacity via Overnomination, a Shipper must have Acceptable Credit Support in place as per Section 3 of the Interconnector Access Agreement.
